





### THE MAIN OBJECTS ANDPURPOSES FOR WHICH THE TRUST ISCREATED ARE;

R) The ownership of all the properties acquired by the Trust shall be vested absolutely with the Trust jointly.

S) There shall be two categories in the Trust and they are trustees and life members. The authors of the Trust above named are hereditary in nature and the authors of the Trustees are main person to maintain the said trust. The executive committee can admit person/s in the Trust of the life member/s as and when the board of Trustees decide by majority and by resolution passed in respect thereto by stipulating such conditions as they may decided from time to time And person who pays the prescribed sum and fulfills the conditions stipulated therefore will be admitted as life member subject to approval of the executive committee and the committee reserves the right to admit or reject any person as life members. A person who is rejected to be admitted by executive as a life member may be admitted by the board and trustees by their majority opinion number of life members to be admitted shall be stipulated and can be varies by the Board of Trustees time to time. In the implementation of the above matters the decision of the majority trustees in a meeting will prevail.

T) Every one of the trustees shall be life trustee, each one of the trustees shall hold office as trustee during his/her life time and shall be entitled to attend all the meetings of the board of trustees and participate of them.

#### 10. THE BOARD OF TRUSTEES

A)The Trust shall be managed by the Trustees who will be hereinafter called as BOARD OF TRUSTEES and the board of trustees shall have a chairman/president, Vice President General Secretary., Joint Secretary Treasures etc., as its office bearer.
